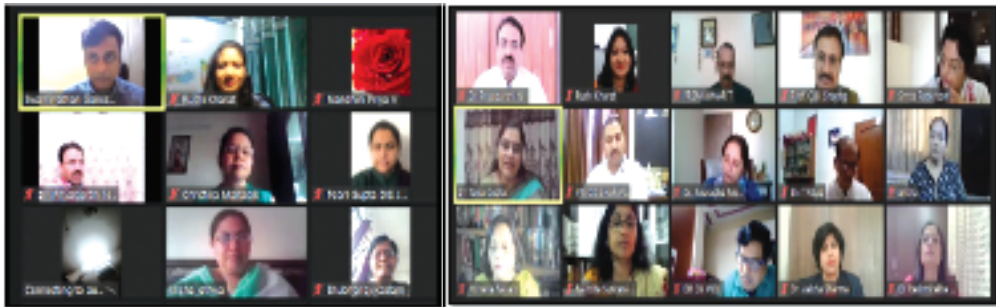
NATIONAL EDUCATION POLICY 2020 : (NEP- 2020)
